Police Activity Updates

July 31st, 2017 through August 6th, 2017

At approximately 1730 hrs. on 7/31/17, officers were dispatched to Smith's Marketplace on a child neglect complaint. Upon arrival, officers found that two juveniles ages 8 and 4 yrs. old had been left unattended in a vehicle while the mother was in the store shopping. The vehicle had been left running with the air conditioner running. The mother was located and educated about the hazards of leaving the children unattended, even with the vehicle's a/c running.

On 8/1/17, pedestrians in the 1100 E. block of 2600 N. reported finding several pieces of mail in the weeds near this location. Officers have been in contact with the addresses, and advised that the mail had been secured in NOPD evidence for safe-keeping until they can claim it.

At approximately 0615 hrs. on 8/2/17, an officer was checking the Smith's Marketplace parking lot when he was flagged down by an employee who reported that sometime between 0300 and 0400 hrs., he had witness two individuals pull in front of the store, which was closed at the time, and load a large box into the bed of the truck before driving away. It was determined that the suspects had stolen merchandise that was on display in front of the store. The subsequent investigation revealed that these suspects had committed similar crimes throughout Weber County and northern Davis County. The person believed responsible for the thefts was identified, and it was discovered that since this theft, he has been arrested on multiple unrelated felony charges and transported to Utah State Prison.

On the evening of 8/2/17, North Ogden Police assisted the Internet Crimes Against Children Task Force, who were serving a search warrant in the 2050 N. block of 400 E.

At approximately 2300 hrs. on 8/2/17, while checking on the restrooms at Barker Park, an officer discovered that someone had thrown a rock, breaking a toilet in one of the restrooms. The rock had been painted with a decorative design.

On the morning of 8/5/17, a resident in the 650 E. block of 3125 N. reported that a window had been broken out of her vehicle sometime overnight.

On 8/5/17, a resident in the 1200 E. block of 3100 N. reported that on 8/4/17, he noticed that a window had been broken out of his vehicle. It appears that a bb or pellet gun, or similar object was used to cause the damage. The victim also advised that he parked the vehicle at this location approximately two weeks prior and that the damage occurred sometime between when it was parked there and 8/4/17.

On 8/6/17, a juvenile resident reported being the victim of a fraud. She advised that she had attempted to sell an item online. She received a check from a "buyer" that was well in excess of the agreed upon asking price, cashed the check, and forwarded the excess money via wire transfer as instructed by the buyer. She also received and cashed a second check, however has not yet forwarded that money. She has since been advised that the checks were fraudulent and that she would likely be responsible for the loss.

This update highlights police activity for the time frame noted, but does not comprise a complete list of activity. Law enforcement sensitive cases, on-going investigations, and many other cases are not included.
