CONSOLIDATED FEE SCHEDULE

A RESOLUTION TO AMEND THE CONSOLIDATED FEE SCHEDULE FOR NORTH OGDEN CITY, UTAH FOR THE LATE FEES CHARGED TO A BUSINESS LICENSE AND WHEN THEY ARE LATE AND MAKING SUCH FEES EFFECTIVE IMMEDIATELY UPON POSTING.

WHEREAS, section 10-1-203 of the Utah State Code states “A municipality may license for the purpose of regulation and revenue any business within the limits of the municipality and may regulate that business by ordinance; and,

WHEREAS North Ogden City adopted provisions for licensing business and said provisions are set forth in Section four (4) of the North Ogden City Code; and,

WHEREAS, North Ogden City adopted on November 9, 2010 business license and disproportionate fees and included said fees in the North Ogden consolidated fee schedule; and,

WHEREAS, the North Ogden City Council determined on June 12, 2012 to reconsider the business license fee; and,

WHEREAS, the North Ogden City Council desires to use the business license fee as an incentive to attract and retain business in North Ogden City.

BE IT THEREFORE RESOLVED by the North Ogden City Council that Section 2 – Fees - Business Licenses of the Consolidated Fee Schedule shall be amended as follows.

SECTION 1.

In addition to the above Business License Fees, the following fees apply:

- Day Care Provider
 - Annual Fire Inspection \$15.00
- Temporary license for Businesses with a combined display and building area covering more than 400 square feet License fee plus \$250.00 refundable deposit.
- Temporary license for Businesses with a combined display and building area covering less than 400 square feet License fee plus \$150.00 refundable deposit.
- Late Fees:
 - Business license renewal fees are due ~~Jan. 15th~~ **one year from the date the certificate of license is issued** at the close of business. ~~All payments on business license renewals received after January 15th will incur an additional late fee (North Ogden City Code 4-1-5A)~~
 - ~~A late fee of 50% of the total business license fee will be charged for all payments on business license renewals received after March 15th.~~ **If any license fee is not paid within two (2) months of the due date, a penalty of twenty-five (25) percent of the amount of the license fee shall be added to the original amount thereof, and if not paid within four (4) months of the due date, an additional penalty of twenty-five percent (25%) shall be added to the original amount. (North Ogden City Code 4-1-5B)**
- Beer Licenses, Class “A” and “B”
 - New Applications \$31.79
 - Renewal \$23.45

SECTION 2. This ordinance shall take effect upon adoption
