82 Mayor Harris mentioned the Orton Park Subdivision proposed on 2100 N and said the Land Use
83 Authority will approve that. He talked about the north boundary line and the tree that ruined the fence in
84 that area. The City is going to go in and take the fence and those trees out; it will be replaced with a
85 railing. Council Member Bigler asked if the developer is going to put the fence up. Mayor Harris replied
86 that it will be on flat ground and they will put the fence up on the back of the subdivision.

88 Council Member Bailey asked if we are giving the developer property. Mayor Harris replied no, the
89 developer will give us a 10 foot grading and drainage easement. He explained the liability issue with kids
90 falling off the edge into the rocks. That is the reason for the railing.

92 Council Member Bigler stated that at North Ogden Park where the ball diamond is on the west side of the
93 grand stand there is an area where someone can fall through.

95 Council Member Hulme said he received an email about Oaklawn Park and consider the access gate being
96 locked. He said Dave Nordquist is aware of the situation and will unlock that gate in the morning and
97 lock it at night but we need to look at another access in and out of Oaklawn Park.
